RESOLUTION OF THE AWARD OF THE CONTRACTING BODY OF THE COMPANY SERVICES AND STUDIES FOR AIR NAVIGATION AND AERONAUTICAL SAFETY S.M.E. M.P. S.A. (SENASA), IN THE TENDER PROCEDURE OF THE 'FRAMEWORK AGREEMENT FOR THE SUPPLY OFSPARE PARTS FOR SCHEDULED AND UNSCHEDULED MAINTENANCE AND THE REPAIR, OVERHAUL AND EXCHANGE SERVICES OF THE PRATT AND WHITNEY ENGINES INSTALLED ON THE FLEETS MANAGED BY SENASA'. TENDER FILE: DSO/516/24.

On July 11th, 2024, the SENASA Contracting body expressed ACCEPTANCE of the AWARD PROPOSAL made by the Contracting Manager of the tender file DSO/516/24, for the celebration of the 'Framework agreement for the supply of spare parts for scheduled and unscheduled maintenance and the repair, overhaul and exchange services of the Pratt and Whitney engines installed on the fleets managed by SENASA' to be awarded by open procedure, in favor of the following companies: AERONÁUTICA DELGADO, S.L., EUROPAVIA ESPAÑA S.A., GECI ESPAÑOLA AEROSPACE SOLUTIONS, S.A., INTEGRACIÓN TECNOLÓGICA EMPRESARIAL, S.L., AVOCET AVIATION LTD., EURAVIA ENGINEERING SUPPLY CO. LTD. and GOLDEN WINGS AEROSPACE INC.

In view of the above, and in accordance with Law 9/2017 on Public Sector Contracts, by which the Directives of the European Parliament and Council 2014/23 / EU and 2014/24 / EU are transposed into Spanish law, of February 26, 2014, the contracting body of SENASA,

HAS RESOLVED

First.- The AWARD of the tender procedure for the celebration of the 'Framework agreement for the supply of spare parts for scheduled and unscheduled maintenance and the repair, overhaul and exchange services of the Pratt and Whitney engines installed on the fleets managed by SENASA', tender file DSO/516/24, to be awarded by open procedure, to the companies AERONÁUTICA DELGADO, S.L., for the lots 1 and 2, EUROPAVIA ESPAÑA S.A., for the lots 1 and 2, GECI ESPAÑOLA AEROSPACE SOLUTIONS, S.A., for the lots 1 and 2, INTEGRACIÓN TECNOLÓGICA EMPRESARIAL, S.L., for the lots 1 and 2, AVOCET AVIATION LTD., for the lots 1 and 2, EURAVIA ENGINEERING SUPPLY CO. LTD., for the lots 1 and 2 and GOLDEN WINGS AEROSPACE INC., for the lots 1 and 2.

It is a framework agreement in which all the terms of the tender are not initially established. The awarding of the based contracts will be carried out summoning the parties to a new tender, in which the award criteria established in section 11.2 of the specifications will be applied (price and, depending on the characteristics of the contract, term of the contract, delivery and warranty period).

Second.- NOTIFY the present award, in accordance with the provisions of article 151 of the LCSP.

Third.- REQUIRE the successful companies to proceed to the formalization of the framework agreement, which must be made no later than 15 working days following the one in which the notice of the award is made, in accordance with the provisions of Article 153.3 of the LCSP.

Fourth.- PUBLISH the present adjudication resolution in the SENASA contracting profile.

Against this Resolution may be filed, within one month of the day following the notification thereof, appeal improper elevation before the Minister of Finance, in accordance with the provisions of Article 44.6 of the LCSP, in concordance with the provisions of Law 39/2015, of October 1, on the Common Administrative Procedure of Public Administrations.
